**1. Welcome Potluck/ Breakfast and Introductions**

The meeting was called to order at 9:15 a.m. Bonner Montler introduced himself and welcomed the attendees. He also introduced Eileen Moreno. He invited everyone to enjoy the breakfast.

**2. Reading and Approval of January Minutes**

Bonner Montler reviewed the January minutes. Eileen Moreno addressed a question from the January meeting stating that parents could use the Achieve 3000 program at home without affecting their students' progress. A motion to approve January's minutes was made by Africa Reese. Lupe Brambila seconded the motion. The minutes were accepted.

**3. Addition to Agenda -- CASPP**

Bonner requested to add discussion about the CASPP (California Assessment of Student Performance and Progress) to the meeting. Lupe Brambila motioned to approve. Juanita seconded the motion.

**4. Local Control and Accountability Plan (LCAP)**

Eileen Moreno presented a video which showed how Digital Learning (technology/ iPads) is being implemented in the classrooms. It showed how students, parents, and teachers respond to the use of iPads in the classroom. It explored current and future possibilities for knowledge and critical thinking.

Ms. Moreno explained that the LCFF (Local Control Funding Formula) determines how much money each school receives. The DELAC group was given booklets which Eileen reviewed, including the amount of funding the schools will receive, emphasizing that a large percentage of that is used to put iPads in the students' hands. She stated that the same presentation will be given to multiple groups to allow for feedback on this proposal.

Currently the Santee District has 6 goals: Language Arts, Mathematics, Academic Performance Index, Engage students, Improve support for specific groups, and Improve parent participation. Ms. Moreno presented the action steps to meet the goals. Eileen allowed the DELAC committee tables to discuss the items in the booklet. She indicated that parents and staff members can contribute feedback to be presented to the board for review. There is a timeline on the back of the booklet with other opportunities to provide input.

**5. Input Survey After Viewing Video – Eileen Moreno – Director Curriculum & Assessments**

Eileen Moreno invited members to participate in a survey about the LCAP. Eileen requested that the DELAC committee write responses on posters to provide feedback about the LCAP. The posters gave opportunities to record input on the schools' current performance, areas of concern, and how the schools are meeting or exceeding expectations in the LCAP goal areas.

6. **Reclassification Criteria 2015 – Bonner Montler – Coordinator Assessment & EL Department**  
114 students are being reclassified at 6pm at Rio Seco School on March 19<sup>th</sup>, 2015. The steps for reclassification are as follows.

1. CELDT Test Scores from Year 2014-15
2. 2014-15 Classroom Assessments
3. 2014 1st Trimester Assessments
4. Teacher/ Administrator Recommendations
5. Parent Notification
6. Two-Year Monitoring (After reclassification, students' progress is monitored for 2 years)

7. **CASPP (California Assessment of Student Performance and Progress) –Bonner Montler**

In May testing for grades 3-5 will be conducted using one to one iPads. For grades 6-8, students will use devices already in the schools. A new site on Santee's webpage is being built containing letters and articles of information on state testing. To find this information, locate *Parent Resources* on [Santeesd.net](http://Santeesd.net) website and click the first link.

Bonner explained that interim assessments were given the past two weeks for 3<sup>rd</sup> -8<sup>th</sup> grade. This year the assessment was piloted in Santee and next year it will be used as a benchmark. For May testing, schools will send out a letter explaining testing.
